#### 3) International Engagement

#### International Ombudsman Summit 2024

The Summit, with the theme "Ombudsman in a Changing World: Learning from the Past; Preparing for the Future", provided a platform for Ombudsman from around the globe to exchange insights and share experiences and best practices. It also enabled meaningful discussion about evolving challenges faced by Ombudsman Institutions, as well as in-depth deliberations on future developments and solutions. Ombudsman Taumoepeau attended the First International

Ombudsman Summit at Hong Kong in early December. The summit also marked the 35<sup>th</sup> anniversary of the establishment of the Hong Kong Ombudsman Office.

#### Commonwealth Forum of National Human Rights Institutions Biennial Conference

The CFNHRI Biennial Conference was held in Apia Samoa on the 17<sup>th</sup> and 18<sup>th</sup> of October in the preliminary meetings leading up to CHOGM 2024. The conference identified effective approaches to ensure the protection of human rights of Commonwealth countries. Dialogue and sharing of best practices included Human Rights issues and deliberations on upholding the rule of law. Ombudsman Taumoepeau was in attendance.

#### **UNCAC** Review



The UN Convention against Corruption (UNCAC) Follow-Up and Implementation Workshop was held in Tungi Colonnade on the 14<sup>th</sup> of November. The workshop included the Attorney General's Office, Anti-Corruption Commissioner's Office, Ministry of Police, Auditor General's Office and the Office of the Ombudsman. Discussions focused on ways to enhance collaboration between government agencies, civil society, and international partners against corruption, and promote integrity and good governance.
